## School Site Council (SSC) News

The SSC met on Feb 10. The main topic of discussion was the Arts/Enrichment curriculum at Lakeshore.

We discussed whether most parents know what Enrichment/Arts programs their kids receive and are parents satisfied with the programs. How do we inform parents, measure satisfaction and move to a defined integrated curriculum? The SSC voted to pay teachers a small stipend to participate in a half-day retreat to discuss enrichment programs and ways enrichment is integrated into the classroom curriculum. All teachers and parents are encouraged to learn more about the programs at Lakeshore.

Budget news: The school will receive the preliminary site allocation and will work on drafting a preliminary budget. The school district is holding a Site Council Summit on March 1, from 8:30 AM to 1:00 PM at Everett Middle School. All are welcome to attend.

# Now taking nominations for 2014-2014 PTA Executive Board

Elections for next year's PTA Executive Board will be conducted at the General Meeting on April 9<sup>th</sup>. We are now collecting nominations for all positions. **If you would like to be nominated or you have someone you think should run, email pta@lakeshoreleementary.org**.

Most positions are perfect for working parents as responsibilities can be done on your own schedule. There are once-monthly evening Executive Board meetings and six General Meetings per year.

**President:** Lead the Board to set the vision and goals for the PTA, ensure compliance with legal and financial regulations, coordinate with other school groups including SSC, Art Committee and Principal.

**Executive Vice President:** Serve as the primary aid to the President and perform their designated duties in the situation of absence or illness. Assist VP's of other areas perform their job duties (Membership, Special Events, Programs and Consultants).

**VP, Membership:** Maintain and/or grow the current membership of 300+ members, which raises \$19,000-\$20,000 annually in membership fees and donations to support PTA-funded programs.

**VP Programs and Consultants**: Manage the success of the enrichment programs including consultant contracts, obtaining feedback from teachers, consultants, and PTA membership.

**VP Special Events:** Manage the teams that drive our signature Community and Fundraising events.

**Secretary:** Keep minutes for all PTA General and Executive Board meetings and post them as a legal record of the association (currently done electronically).

**Treasurer:** Responsible for all of the unit's finances.

Financial Secretary: Handles all the unit's deposits.

**Auditor:** Audit the books, financial records and procedures of the unit to ensure legal and organizational compliance.

**Parliamentarian:** Manages the unit's bylaws by enforcing, reviewing, and updating as appropriate.
